

## HISTORIC FORMS COLLECTION

### Summary

The materials in this collection were created by USCIS or one of its predecessor agencies. The collection is in English, except when forms have been translated into other languages and these are noted on the form title or number. The physical collection is housed in twenty (20) linear feet of vertical filing cabinets. There are items of the collection housed in the high-density stacks, the poster collection or in the vertical files. Most forms have been digitized.

### Access and Use

Materials are housed in the USCIS History Office and Library and are non-circulating. Access is available during normal business hours; research appointments are preferred. Public forms may be used without exception. Other forms are internal use only and marked **(IUO)**. Digitized forms can be requested by email: [cishistory.library@uscis.dhs.gov](mailto:cishistory.library@uscis.dhs.gov). If the notation **(no copy available)** is next to a listing that means that neither a physical or digital copy is available and only the name of the form is known. Historical forms may use terms that are now considered offensive. Form titles have changed over the years and if more than one title was used it is also included in the contents list.

### Background Information

The current collection is a combination of two earlier collections. At the inception of the History Office and Library in the early 1990s a collection of forms was created. Later, the office that is now the Office of Intake and Document Protection (OIDP) donated forms that are in the dark green folders. The two collections were combined for the ease of digitization.

### Scope and Content

Historic forms, form review requests, identification cards, printing proofs, memorandum, notes, books, pamphlets, envelopes, cover sheets, and brochures ranging from the 1940s to the present. This collection of forms is not exhaustive.

### Arrangement

The physical collection is arranged in alpha-numerical order. Individual form folders are arranged chronologically from oldest to newest, with supporting documentation arranged next.
